Uisce Eireann will not grant a connection to the existing public Water supply network fronting this site on the grounds that there is insufficient water pressure

.Initially a preplanning meeting was held with Tipperary County Council and arising from same site

surveying was carried out.Plans were drawn at a significant cost and having secured an interested party to proceed with the development of my lands (TYLA00003199)it appeared it was a formality to apply and get permission for a water connection to the main fronting the site and submit the planning application. The developer with whom I had entered into a provisional agreement lodged the application with Uisce Eireann in August/September and not only has he failed to get approval for a connection to my site but he has yet to get approval for a connection to a large public housing (turn key) development with planning permission in the same area. I have tried to get something in writing in regard to my site and failing same contacted the water caretaker in Roscrea who advised me that the network has to be upgraded before any further connections will be granted in this area. It is extremely difficult to ascertain the extent of the upgrade required but there is mention of upsizing a long section of piping and possibly booster pumps. I can not regrettably foresee it possible to proceed with the development of my site anytime soon and should in the circumstances be excluded as being liable for RZLT.

The lands are, as you are no doubt aware zoned for housing and I have every intention of proceeding with its development when serviced with a water supply.
