Uisce Éireann welcomes the opportunity to comment on the Proposed Material Alterations to the Draft Carrick-on-Suir Local Area Plan 2025-2031 (Draft LAP). We welcome the inclusion of Proposed Material Alterations arising from your consideration of our initial submission on the Draft LAP. Our observations and comments on the proposed amendments in relation to public water services are below and we will continue to engage with the planning department as the LAP process progresses.

Uisce Éireann welcomes the proposed amendments to Section 4.2.2 (Three Bridges Business Park & Ballylynch Business Park) of the Draft LAP regarding the significant landbank zoned for employment uses and the requirement to ensure these lands are developed in a phased, cohesive and sequential approach. We also welcome the proposed amendments to Section 5.1 (Residential Development) of the Draft LAP to require a master planning type approach to the delivery of infrastructure for large scale residential development. This would ensure that sequential connections to water supply and wastewater infrastructure could be undertaken in the most efficient manner.

Our comments on the proposed amendments to the written statement (Section 3.0 of the Proposed Material Alterations) and proposed amendments to the maps (Section 9.0 of the Proposed Material Alterations) are below. We have no comments on the Carrick-on-Suir Town Centre First Plan.

Carrick-on-Suir is served by the Carrick-on-Suir Water Resource Zone (WRZ). Uisce Éireann has indicated that there is potential spare capacity. Some capacity constraints exist however and connection applications to Uisce Éireann will be assessed on an individual basis considering their specific load requirements. Uisce Éireann publishes Water Supply Capacity Registers annually for each county. The latest capacity register for the county was published in June 2023 and indicates that the Carrick-on-Suir Water Resource Zone (WRZ) has potential spare capacity available. Some capacity constraints exist however, Connection applications will be assessed on an individual basis considering their specific load requirements. Significant rehab works to the water supply network were completed in the town in 2022. Local network upgrades would need to be delivered to provide capacity to individual sites, these can be customer driven/funded in accordance with **Uisce** Éireann's Connections Charging Policy.

# Policy 8.2

Support the sustainable and efficient use of existing capacity in water service; permit new connections to the Carrick-on-Suir public water and waste water supply; and safeguard the integrity of the water supply and waste Where local network water network. upgrades are required, to ensure that capacity is provided to individual sites in the Uisce Éireann accordance with Connections Charging Policy and Uisce Éireann's Connections and Developer process. Service New connection public applications to the water and should wastewater infrastructure submitted directly to Uisce Éireann.

In order to clarify the requirements of Policy 8.2 and the roles of the council and Uisce Éireann, we suggest the following changes to the policy:

Support the sustainable and efficient use of existing capacity in water services; support permit new connections to the Carrick-on-Suir public water and waste water wastewater supply; and safeguard the integrity of the water supply and waste water wastewater network. Where local network upgrades are required, to ensure that capacity is provided to individual sites in accordance with the **Uisce** Éireann Connections Charging Policy and Uisce Developer Éireann's Connections and New connection Service process. applications to the public water and wastewater infrastructure should he submitted directly to Uisce Éireann.

# 9.0 Proposed Amendments to the Maps

In regard to the proposal to 'Amend the zoning of land at the park to the South East of Dillon Bridge from 'Community Services and Infrastructure' to 'Open Space and Recreation', it is not clear which part of the site would be removed from the Community Services and Infrastructure zone, although the rezoning appears to relate to the northeastern corner of the site and the eastern boundary of the site. One of the reasons for this change is to 'remove area of land within flood zones from 'Community Services and Infrastructure' use'. However, we note that the site passed the Justification Test included in the Proposed Material Alterations and 'Part 1 & 2 of the test found that it is considered appropriate to retain the zoning designation'.

As noted in the Justification Test, the site is already developed as 'Wastewater Infrastructure' which serves as an essential service, and 'These lands are fully developed, facilitating the provision of an essential public service'. Uisce Éireann agrees with the comment in the Justification Test — rezoning the land may restrict works associated with the wastewater infrastructure that may be required in the future. We oppose the rezoning of any part of the site to Open Space and Recreation.
